Harga sawit yang stabil tinggi menyebabkan permintaan pupuk kian tak terbendung. Hal ini mendorong PT Saraswanti Anugerah Makmur Tbk (SAMF) bersiaga dengan mengantisipasi persediaan bahan baku agar SAMF dapat memenuhi permintaan pupuk tersebut.

Sebagai upaya untuk menjamin ketersediaan bahan baku, SAMF resmi bekerjasama dengan salah satu distributor pupuk jenis KCL/MOP, CHAMPA INTERNATIONAL Pte. Ltd, yang berkantor di Singapura, untuk pengamanan kebutuhan bahan baku sepanjang tahun 2022.

Pengamanan kebutuhan bahan baku KCL/MOP sebanyak 75.000MT diperuntukan bagi salah satu anak usaha SAMF, yakni PT Anugerah Pupuk Makmur (APM). Bahan baku akan dikirim dari Laos via Vietnam ke lokasi pabrik APM yang berada di Sampit, Kalimantan Tengah.

The stable high price of palm oil causes the demand for fertilizer to become increasingly unstoppable. The increasing demand has prompted PT Saraswanti Anugerah Makmur Tbk (SAMF) to be on the alert by anticipating the supply of raw materials so that SAMF can meet the need for fertilizer.
