**Penjualan Pupuk SAMF Naik 91 Persen hingga Juni 2023**  
***SAMF Fertilizer Sales Increase 91 Percent until June 2023***

Jakarta - PT Saraswanti Anugerah Makmur Tbk (SAMF) sepanjang 6 bulan pertama tahun 2023 berhasil membukukan penjualan sebesar Rp2,77 triliun, atau melejit 91,12% dibandingkan periode yang sama setahun sebelumnya. Di sisi lain, emiten berkode saham SAMF ini mencetak lonjakan laba tahun berjalan sebesar 70,52%.

"Kami bersyukur kinerja semester pertama 2023 sangat baik karena permintaan pasar untuk pupuk NPK khususnya dari kalangan perkebunan sawit, karet, kopi dan kakao masih sangat tinggi. Peningkatan penjualan tidak saja didukung oleh adanya demand yang cukup besar, tapi juga karena naiknya volume pupuk yang terjual. Akhir Juni 2023, penjualan Perseroan mencapai Rp2,77 triliun, sedangkan periode sama tahun 2022 sebesar Rp1,45 triliun" Ungkap Ir. Yahya Taufik, Direktur Utama Perseroan.

Sementara itu, per akhir Juni 2023, laba tahun berjalan Perseroan melonjak 70,52% menjadi Rp245,23 miliar, dibandingkan perolehan enam bulan pertama di tahun 2022 sebesar Rp143,81 miliar.

*Jakarta - During the first six months of 2023, PT Saraswanti Anugerah Makmur Tbk (SAMF) successfully booked sales of Rp2.77 trillion, or increased 91.12% compared to the same period a year earlier. Meanwhile, the issuer coded as SAMF scored a 70,52% surge in profit for the year.*

*"We are grateful that the first half of 2023 performance was very good because the market demand for NPK fertilizers, especially from oil palm, rubber, coffee, and cocoa plantations, is still very high. The increase in sales was not only supported by a large enough demand but also because of the increase in the volume of fertilizers sold. At the end of June 2023, Company's sales reached Rp2.77 trillion, while the same period in 2022 amounted to Rp1.45 trillion," said Ir. Yahya Taufik, President Director of the Company.*

*Meanwhile, as of the end of June 2023, Company's profit for the year jumped 70,52% to Rp245,23 billion, compared to Rp143.81 billion in the first six months of 2022.*
